- Supplier Database Form
- Central Supplier Database Report
- Tax Compliance Pin
- Rates Clearance Certificate and statement not older than 3 months or formal lease agreement signed by both parties
- Confirmation of banking details
- Current Catering Certificate (for catering services)
- CIDB Certificate (where applicable)
- Copy of Company Registration Certificate from CIPC
- Certified copies of identity documents of shareholders/directors of the company

**NB: CERTIFICATES MUST NOT BE OLDER THAN 6 MONTHS.**
